



## Waiver of Liability and Release for use of Batting Cages

In consideration of the services provided by Stealers Baseball and Softball Club Inc, in any capacity, I now agree and certify as follows:

1. I acknowledge and fully understand that I, \_\_\_\_\_, the participant (if participants is 18 years of age or older) or parent/legal guardian of the above listed minor participant, will be engaging in activities that may involve risk of serious injury which might result not only from my own actions, inactions, or negligence, but from the actions, inactions, or negligence of others or the conditions of the premises or of any equipment used. Further, that there may be other risks not known or not reasonable foreseeable at this time. The risks may include, but are not limited to: nature of the activity, latent or apparent defects of conditions in equipment or property supplied by Stealers Baseball and Softball Club Inc or other entity; acts of other participants in this activity, employees or agents of Stealers Baseball and Softball Club Inc; my own physical condition, acts of omissions; conditions of Stealers Baseball and Softball Club Inc facility and surrounding grounds or terrain and accidents connected with their use; first aid emergency treatment or other services.

I hereby certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in these activities or alternatively I agree to bear the cost of such injury or damage myself. I further certify that I have no medical or physical conditions, which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risk that may be created, directly or indirectly, by any such condition.

## Batting Cage Rules

1. Batters **MUST** wear helmets inside tunnels at all times.
2. Only Coaches are permitted to adjust pitching machines.
3. A waiver must be signed before use of any of the equipment by any user who is 18 years of age or older (Parent/guardian must sign for any minors).
4. Adults are responsible for the actions of the youth in the training area. Misconduct will result in immediate termination of privileges. Horseplay/fooling around will not be tolerated.
5. No food or drink allowed in the batting cages.
6. All balls must be picked up and returned to their proper place after use.
7. Batters must wear appropriate shoes. (No Cleats)
8. No person under the influence of Drugs or Alcohol is permitted to use the batting cages.



9. Balls may be pitched at any time. BE ALERT at all times.
10. Anyone under the age of 16 must have adult supervision on site. Helmets must be provided by the user.
11. Do not throw balls back at pitching machines.
12. This is a family atmosphere, no profanity or vulgar language/gestures will be permitted.
13. CAUTION! Injuries could result from the use of these devices. Users should assume the inherent risks of batting baseballs and softballs. If users have any questions about the use of these devices or the inherent risks associated with the use of these devices, ask a committee member before using the batting cages.
