What a pleasure it is to provide this report for the 2022/23 juniors baseball season, a phoenix of a season which rose from the ashes of the previous few seasons which were severely affected by COVID-19 disruption and rainouts. On the contrary, the 22/23 season played a full 21 rounds- including finals rounds, without a single full-round wash out!

Participation numbers improved from the previous season decline. Ku-ring-Gai Stealers Baseball and Softball Club Inc Notes to the Profit and Loss Account FYE 31 March 2023

1. Income

1.1. Summer Seniors Baseball

On budget.

1.2. Summer Juniors Baseball

Performed \$5k or 21% better than budget.

1.3. Winter Seniors Baseball

Performed \$1.3k or 16% better than budget.

1.4. Softball

Performed \$1.8k or 53% better than budget.

1.5. Uniform Sales

Down \$(1.8k) or -42% to budget. This is unusual given the increased income from Junior Baseball and Softball registrations.

1.6. Canteen Takings

Performed \$1.7k or 100% better than budget. Note that some of this money may be for funding softball rep participation (re: cake stall fundraiser).

1.7. Miscellaneous Income

Performed \$848 or 170% better than budget. Largely third-party use of the batting cages.

1.8. Jubilee Cup & Other Rego

No gala days were held during the year.

1.9. Sponsorships and grants

Down \$(31k) or -92% on budget and down -95% on last year's income. This year we only obtained two small contributions from Baseball NSW Grassroots and Ku-Ring-Gai Council.

1.10. Total Income

While mitigated somewhat by a boost of income in baseball and softball registrations, the loss of any significant sponsorship or grant income resulted in an overall decline in operating income of \$(42k) or -34% on last year's income and a final result \$(31k) or -21% down on budget.

2. Cost of Sales

2.1. Tournament costs (in-out)

This is predominantly a clearing account for the Tamworth June Baseball Carnival and aims for breakeven. It is currently in negative expenditure as players have begun to pay registration fees for the 2023 tournament.

2.2. Purchases for Resale-Uniforms

Expenditure is down \$1.9k or 64% in line with reduced uniform sales (see 1.5 above).

2.3. Capitation - BA & BNSW

Obsolete line item as this is now garnished at the time of each player's registration.

2.4. Capitation - RHBL

RHBL is yet to send us an invoice for the 2022-23 season, consequently no expenditure but \$3.4k expected.

2.5. Capitation - PCBL

Expenditure \$2.7k or 17% higher than budget however we are currently \$745.75 in credit with PCBL. Payment to PCBL this year includes \$670 in fines (E2 Road Runners \$330, A2 Swingers \$150, C2 Numbats \$110, D2 Shoeless Joes \$80).

2.6. Capitation - Softball

NSDSA capitation is now garnished at the time of each player's registration. The negative expenditure of \$940 is a credit from Softball NSW.

3. Expenses

3.1. Bank & Government Charges

Undeerbudget.

3.2. Advertising

\$703 or 31% overbudget. Several social media boosts were included this year.

3.3. Commissions Paid

None during the year – related to poor performance of 'Sponsorship and grants' income (see 1.9 above).

3.4. Gala Day & Other Subscriptions

Stealers had no club-funded participation in gala days this year.

3.5. Insurance

No payment for insurance as it is understood that required insurances are included in association/state/federal bodies capitation fees.

3.6. Baseball Equipment

Expenditure overbudget by \$6.5k or 233% due to purchase of new Zooka machine and catchers gear.

3.7. Baseballs

Expenditure overbudget by \$2k or 100% due to replenishment of balls especially for training.

3.8. Machine Maintenance

Overbudget by \$1.3k or 192% resulting from overdue maintenance to Zooka machines.

3.9. Training and Camps

Underbudget due to only one player participating in softball official training.

3.10. Ground & Hall Hire

Overbudget by \$14k or 61% but includes \$10k of unpaid invoices from the previous year and \$5.5k of new recurring expenditure related to clubhouse/batting cages rent.

3.11. Ground Maintenance

Overbudget by \$1.5k or 8%.

3.12. Postage & Communication

None.

3.13. Web Site Expenses

\$300 overbudget.

3.14. Season Start Up Costs

\$400 overbudget.

3.15. Registration & Meeting Expense

None.

3.16. Miscellaneous Expenses

On budget and similar to last year. Predominantly juniors umpiring expenses.

3.17. Presentation Day & Awards etc.

Increase of \$2k on last year, as presentations were reinstated after the COVID lockdown.

3.18. Clubhouse/Committee Amenities

None.

3.19. Telephone

None.

3.20. Total Expenses

\$28k overbudget due to unbudgeted expenditure in Equipment and Ground Hire.

4. Other Income

4.1. Interest Income – overbudget due to increased interest rates on bank savings account.

5. Other Expenses

5.1. Interest Expense – none.

6. Net Profit / (Loss)

The net loss of \$16k is broadly attributable to lack of Sponsorship/Grant income coupled with increased expenditure on Equipment and Ground Hire. This loss results in a commensurate depletion of the cash reserves and reduction of equity on the balance sheet.
