Fred has been tirelessly keeping the canteen stocked and running, serving delicious treats from the BBQ, the fridge, the coffee machine and snack bar, even after his kids had moved on from junior baseball and no longer were playing for the club.</i> <i>Fred's association with the club began in 2011, when his son Justin joined to play Little League. As Justin's baseball career developed, Fred was always involved, managing teams or helping with the coaching, even when Justin had graduated from juniors, Fred would join the touring squad at the annual Tamworth Baseball Carnival, ensuring the players were kept fed through selfless runs to the local shops or take-away.</i> <i>Fred came on the committee in 2015 and started his involvement with the canteen by managing the BBQ roster in 2016. Filling the large boots of Chris Rainnie in subsequent years, Fred took over the running of the canteen, and ensured that as well as the tantalising sweets and chips, there were also healthy options on offer.</i> <i>Fred is the consummate club person, expecting no reward other than the pride of a job well done and knowing that he contributes to the joy of hundreds of club members who play the best game each week.
